AFG seeks to support organizations that lack the tools and resources necessary to more effectively protect the life and safety of the public and their emergency-response personnel with respect to fire and all other hazards. Eligible Activities: Fire department priorities include training, equipment, personal protective equipment (PPE) gear, firefighter wellness and fitness, modifications to fire stations and facilities, and firefighter vehicle acquisition.

The intensive training school is led by Paul Gallagher, Owner, and Head Trainer of Maine Specialty Dogs. The State Farm Arson Dog Program was established with the Maine State Police under the guidelines of the Maine Criminal Justice Academy.
